200 Church Street Landisville, PA 17538 VERIFICATION OF ADDRESS IN CASE OF LIVING WITH LEGAL RESIDENT

Under Section 1302 of the Pennsylvania School Code:

A child shall be considered a resident of the school district in which his parents or the guardian of his person resides. When a resident of any school district keeps in his home a child of school age, not his own, supporting the child gratis as if it were his own, such child shall be entitled to all free school privileges accorded to resident school children of the district, including the right to attend the public school maintained in such district or in other districts in the same manner as though such child were in fact a resident school child of the district, and shall be subject to all the requirements placed upon resident school children of the district. Before accepting such child as a pupil, the Board of School Directors of the district may require documentation of residency.

GUIDELINES FOR REASONABLE INFORMATION TO SUBSTANTIATE SWORN STATEMENT BY RESIDENT UNDER 24 P.S. §13-1302

Pursuant to Act 35 of 2001, school districts may, upon adoption by way of a school board policy, request copies of one of the items in each category below, in substantiation of the assertions made in the sworn statement of the resident. If the school district has elected to require substantiating information and advised the resident thereof, then the resident must submit the required documentation along with the statement before the district is required to accept the child as a student. Reasonable information to substantiate the statement shall include the following:

Signer is a Resident of the District as Evidenced by:

_ School/County/Per Capita Tax Bill
_ Rental Agreement or Lease
Parent/Legal Guardian is a temporary resident of the district as evidenced by:
Utility bill,
Pennsylvania Department of Transportation identification or drivers license, or
Pennsylvania Department of Transportation vehicle registration, or
Copy of State/Federal program enrollment, or
Copy of paycheck stub with name and address of employee and employer
 Utility bill, Pennsylvania Department of Transportation identification or drivers license, or Pennsylvania Department of Transportation vehicle registration, or Copy of State/Federal program enrollment, or

All signers must provide valid photo identification
