VERIFICATION OF ADDRESS FOR SHARED HOUSING

NOTICE OF PENALTY FOR PROVIDING FALSE INFORMATION: A PERSON WHO KNOWINGLY PROVIDES FALSE INFORMATION FOR THE PURPOSE OF ENROLLING A CHILD IN A SCHOOL DISTRICT FOR WHICH THE CHILD IS NOT ELIGIBLE COMMITS A SUMMARY OFFENSE AND SHALL, UPON CONVICTION FOR SUCH VIOLATION, BE SENTENCED TO PAY A FINE OF NO MORE THAN THREE HUNDRED DOLLARS (\$300) FOR THE BENEFIT OF THE SCHOOL DISTRICT IN WHICH THE PERSON RESIDES OR TO PERFORM UP TO TWO HUNDRED FORTY (240) HOURS OF COMMUNITY SERVICE, OR BOTH. IN ADDITION, THE PERSON SHALL PAY ALL COURT COSTS AND SHALL BE LIABLE TO THE SCHOOL DISTRICT FOR AN AMOUNT EQUAL TO THE COST OF TUITION CALCULATED IN ACCORDANCE WITH SECTION 2561 OF THE PUBLIC SCHOOL CODE DURING THE PERIOD OF ENROLLMENT.

GUIDELINES FOR REASONABLE INFORMATION TO SUBSTANTIATE SWORN STATEMENT BY RESIDENT UNDER 24 P.S. §13-1302

Pursuant to Act 35 of 2001, school districts may, upon adoption by way of a school board policy, request copies of one of the items in each category below, in substantiation of the assertions made by the resident. If the school district has elected to require substantiating information and advised the resident thereof, then the resident must submit the required documentation along with the statement before the district is required to accept the child as a student. Reasonable information to substantiate the statement shall include the following:

Signer is a Resident of the District as Evidenced by one of the following:

- Current utility bill
- Hempfield School District Property Tax Bill
- Lease (acceptable if signed in the past 30 days)
- Settlement paperwork (acceptable if signed in the past 30 days)

Parent/Legal Guardian is a temporary resident of the district as evidenced by one of the following:

- Current utility bill
- Pennsylvania Department of Transportation vehicle registration
- Copy of State/Federal program enrollment
- Copy of paycheck stub with name and address of employee and employer

Resident and Parent/Legal Guardian must provide valid photo identification.
