Pursuant to Act 35 of 2001, school districts may, upon adoption by way of a school board policy, GUIDELINES FOR REASONABLE INFORMATION TO SUBSTANTIATE SWORN STATEMENT BY RESIDENT UNDER 24 P.S. §13-1302

Pursuant to Act 35 of 2001, school districts may, upon adoption by way of a school board policy, request copies of one of the items in each category below, in substantiation of the assertions made in the sworn statement of the resident. If the school district has elected to require substantiating information and advised the resident thereof, then the resident must submit the required documentation along with the statement before the district is required to accept the child as a student. Reasonable information to substantiate the statement shall include the following:

1-Signer is a Resident of the District as Evidenced by:

_ Deed

_ School or County Tax Bill

_ Rental Agreement of Lease

SIGNER IS SUPPORTING THE CHILD GRATIS demonstrated through a:

- _ Copy of completed IRS form transferring tax exemption of child to resident, or
- _ Copy of Federal or State tax form which lists child as a dependent of resident, or
- _ Copy of completed county form transferring child support payments to resident, or
- _ Copy of completed State form notifying Department of Welfare of child's new residence,
- _ Copy of insurance policy/card/statement listing child as eligible for services, or
- _ Copy of lease/rental agreement identifying the child as a tenant
