## Dual Custody Transportation Request Form 2024-2025

1. **Your Custody Order or Affidavit must be on file with the Registration Office for each student.**
2. This form is to be used to request transportation to both parents' homes. **BOTH parent signatures and a completed calendar are required.**
3. Approval must be confirmed BEFORE the student may ride.
4. Sufficient time is needed for driver Notification and Implementation.
5. Changes to this arrangement should be given to the Transportation Office in writing using this form.
6. For both parents to receive robocalls, it is recommended that one parent has their mobile number listed as the Home Phone # under demographics in PowerSchool and the other parent be listed as the primary contact. You can make this change in the PowerSchool Parent Portal or by emailing your request to [registration@hempfieldsd.org](mailto:registration@hempfieldsd.org).
