GEERS Funding

- Case managers used state algorithm to determine student eligibility.
- We had 6 students demonstrate eligibility for remediation.
- Our small number of students was attributed to our return to inperson instruction in August 2020.
- Given the limited number of students, our total expenditures were \$6,950.62

Requirements

- 20% reservation to address the impact of lost instructional time (research-based programs)
- Remaining funds emphasizing educational equity in expending ARP ESSER funds
- Remainder of total funds can be used for non-instructional expenditures.



Requirements (Continued)

The LEA must take educational equity into account in planning for and expending ARP ESSER funds, including but not limited to implementing an equitable and inclusive return to in-person instruction. Activities under ARP ESSER should specifically address the disproportionate impact of COVID-19 on certain groups of students.

Observations

- Staff and Community identified the same top 3 priorities
- Priorities for Learning Loss differed slightly in the 3rd priority
- Comments on additional ideas for ESSER III funds centered around broad topics of:
 - Pay, Retention/Recruitment
 - Social/Emotional Support (staff and students)
 - Learning Loss Support
 - Instructional Ideas
 - Facility Improvements
 - Other (smaller class sizes, full day Kindergarten, helping vulnerable populations, etc.)



Non-Instructional Expenditures

Allocation: \$4,880,597

Recruitment / Retention Incentive Plan	\$2,700,000
Building Improvements: Upgrades, air quality/ventilation, etc.	\$2,180,597

Instructional Expenditures

- Allocation: \$1,220,150
 - Purchase updated programs/materials/resources to address deficits in core instruction and materials for students
 - Math, ELA, technology, social emotional learning/wellness



7% Set Aside (ARP ESSER)

- Allocation: \$474,165
