Dear Parents/Guardians of Hempfield Instrumental Music Students:

The purpose of this document is to notify you of the school district's annual rental fees for students using instruments owned by the school district during in the 2016-2017 school year. These fees are to be applied toward our allocations for instrument repairs and replacement.

We will continue using the same two-tiered structure as before, **with no increase in fees** for the 2016-2017 school year:

- (1) a **rental/maintenance fee** for students who elect to use school district instruments as their *primary* instruments, often including one for practice at home and one for use in school; and
- (2) a **convenience fee** for students who may have an instrument at home, but who also might use school district instruments at school because their personal instrument may be challenging to transport; or because they have shown interest in switching to another instrument; or because their teacher may have recommended changing instruments for balance considerations.

**[Please note:** The convenience fee will also be applied for **all percussionists** at the Middle School and High School levels.]

We will continue using the same fee scale as students move through the Elementary, Middle School, and High School levels. Twice a year, you will receive an invoice from the district's Business Office. You will have the option of paying your fee for the full year or in two installments. Families who are eligible for economic hardship status will be exempt from paying the fee. If your child would potentially be unable to participate in the instrumental music program as a result of this fee, please contact the Student Services Office at (717) 459-9009 for additional information. We will not charge any additional fees for the use of these instruments over the summer for continuing lessons.

<b>Elementary (Grades 4-6)</b>	<b>\$60 per year (two \$30 installments)</b> Fee includes home practice instrument AND instrument used in school if available. (Mostly for Cellos, String Basses, French Horns, Baritone Horns, Tubas and other miscellaneous instruments as available)	<b>\$20 per year (two \$10 installments)</b>
<b>Middle School (Grades 7-8)</b>	<b>\$80 per year (two \$40 installments)</b>	<b>\$20 per year (two \$10 installments)</b> (Including <b>all percussionists</b> , students asked to play Oboes, Bassoons, Bass and Alto Clarinets, Tenor and Baritone Saxophones, and students who elect to switch instruments)
<b>High School (Grades 9-12)</b>	<b>\$100 per year (two \$50 installments)</b> Fee will include the use of concert band AND marching band models of the same instrument (i.e., French Horn and Mellophone or marching and concert tubas)	<b>\$20 per year (two \$10 installments)</b> (Including <b>all percussionists</b> and students asked to play Bass and Alto Clarinets, Tenor and Baritone Saxophones, and some instruments for Marching band and/or jazz band as needed)

**Please note: There is a family expense cap of \$500 per year family for families who have one or more children participating in extracurricular activities and using HSD instruments.**

As in the past, we certainly do not wish to limit opportunities for students who want to learn to play a musical instrument through the district! Again, we ask anyone who may have excellent-quality, unused instruments at home to consider donating that instrument to the school district so other, less fortunate students may have the same opportunity to learn an instrument at reduced costs. Please feel free to email me if you may have an instrument in excellent condition to donate, and I will gladly write you a formal acknowledgement of a valued charitable contribution for tax purposes.

Please do not hesitate to contact me or your student's instrumental teacher directly if you have any concerns or questions regarding the application of this rental program. Thank you for your continued support of our music department.
